Dear Representative Frankel,

The purpose in writing you today is to set aside partisan differences in order to serve the people of Florida's 21st Congressional District as well as Americans across the nation during the Coronavirus Pandemic that the CDC estimates will result in the deaths of 200,000 to 1.7 million Americans.

Individuals who are banned or temporarily suspended on Twitter or Facebook are quite literally cut off from real-time crisis information that is being disseminated by local, state and federal authorities in order to save the lives of Americans.

This is unacceptable. Big Tech's political bias will lead to increased infection rates and the deaths of even more Florida residents and Americans, all because we don't share Silicon Valley's political views.

As you are a member of Congress, I ask that you demand from Facebook and Twitter that they reverse the bans and suspensions of all Americans until this national threat passes.

Until that happens, as I am leader within the community of banned Americans, I have alternative access to reach district residents and millions of other Americans who have been banned or suspended from Twitter and Facebook and will not receive lifesaving information regarding the Coronavirus.

I am requesting your immediate cooperation to inform banned and suspended Americans with real-time, lifesaving information from local, state and federal authorities.

I am offering a gateway to reach this community with real-time information and tips that will increase the health and safety of our community that is home to over 180,000 Senior Citizens who are most vulnerable to COVID-19.
